- Proposed supervision, including the name and title of the supervisor. Please note that the supervisor is not required to be an attorney;

 Contact information (including phone number) for proposed supervisor, and logistical point of contact for Justice Catalyst, if different;

 If the fellow's project is predominately focused on representing clients, including a public agency or the people represented by that agency, a description of the organization's professional liability and malpractice insurance and a statement confirming the fellow's eligibility for coverage;

 If the host organization will be unable to offer \$70,000 starting salary plus benefits for the fellow, a brief explanation of why, and an indication of what the base salary and benefits will be;

– For nonprofit 501(c)(3) organizations, a copy of the $501(c)(3)^*$ determination letter granting the organization tax-exempt status.
